MKL CC Meeting, January 14, 2020

Present: Gail Allyn, Wendy Hamilton, Alison Maxwell, Kara Stires.

Gail joined us as a liaison from the Lakeshore/Association Board.

We discussed a number of topics:

Welcome Bags

Alison and Kara have purchased items to gift to new residents. We are awaiting the MKL tote bags from Joan Haynsworth so that they can be delivered. It was agreed that it would be useful to also include slim binders containing the by-laws for the boards, telephone list, map and historical information, since it has been some time (10 years +) since this was done. Alison and Gail agreed to work together to compile this.

Joan also has a collection of MKL merchandise, including t-shirts and can cozies which she has asked the CC board to take ownership of. Alison will put the merchandise in plastic bins for storage in the clubhouse basement. Joan has some money to be depositied in the CC bank account, as well as a bill for reimbursement for the purchase of new t-shirts, which she will pass on to Kara (Treasurer). We agreed to try to sell these items at forthcoming parties.

Replacement for Clay

Clay Bogusky (Bar Chair) resigned in December 2019. Trevor Hamilton has agreed to manage the bar until the position can be filled following the annual meeting in June. In the meantime, it was suggested that Katie Stanley be invited to join the Board to boost our numbers. Marta and Wendy are considering running again come June. Gail suggested that we ask Lori Denson to form a nominating committee in advance of the June meeting. She has done this very successfully for the Association in the past and may have ideas of who might be a good fit for vacant positions.

Board liaison

We are looking to improve communication between the 2 boards and will endeavor to have someone from the opposite board attend each of the other meetings. Gail, Wendy and Barbara will discuss how best to achieve this.

John Murray has taken on the preparation of the Lake newsletter. Wendy has been contributing details of the social calendar. We agreed that it would be good to have the opportunity to review all information before the newsletter is distributed – Gail will ask John.

Upcoming Parties

We will consider increasing the price of a glass of wine after monitoring sales over the next few parties and also remind party organizers that we are taxed on party income so this must be factored into event ticket prices. Selling the lake merchandise should help a little too!
