Lakeshore Annual Meeting

The annual meeting of the Lakeshore Company was held on Saturday, January 15, at the clubhouse.

Newton White gave the water company report. Following are excerpts from this report:

Pump # 2 is old and may have to be replaced soon. Newton and Jim Irving installed a new pressure switch in pump-house # 1 to improve its reliability as a backup system.

The state now requires daily testing of chlorine measurements. Members of the VSA will assume that task.

In the near future, a backup generator will be installed to be used in case of power outages.

The inside of the horizontal water tank was sandblasted, coated with epoxy and sealed at the seams. The cost of this repair was \$17,000.

is and to keep a clear path from the valve to the road.

The water report was enhanced with pictures revealing the inner workings of the water system and life inside the refurbished horizontal water tank

Larry Bell gave the dam report. We are presently waiting for the state to approve our loan application for funds to do the work necessary to bring our dam into compliance with state requirements. Our application was filed in a timely fashion and hopefully will be approved by 1st quarter 2005. We are lining up contractors and the issue of hiring someone to oversee the project is being addressed.

In Fenton Chaney's absence, the treasurer's report was giving by Bobbi Coulter. The community voted to approve the usage of proceeds from the 2003 Land Sale for the Dam projects and Water Co. improvements.

Gail Allyn reported on the work of an

organizational study committee, consisting of Gail Allyn, Lori Denson, Terry Dwyer, Austin Godfrey, Karen Morrison, and Mick Merenda. The committee has been looking at the organizational structure of MKL and possible ways to improve it by consolidating MKL's three governing organizations into a single homeowner's association.

Jack Dusinberre, an attorney who specializes in home owner associations, was

hired to review the committee's work and to make his own recommendations. At a December meeting of the combined boards, he made the following observations: Home owner associations generally are non-profit groups and do not pay taxes. Lakeshore is presently a forprofit corporation and could possibly be changed to the more favorable tax status of non-profit.

From a liability standpoint, it would be better for Country Club to have its own insurance policy and not be linked to the other two groups.

We have a higher amount of community participation in the operation of the community and the fees we pay are lower than other homeowner associations.

Our present shareholder status and the joint ownership of saleable property, may complicate changes to our structure.

The estimated cost to do the necessary legal work for a reorganization plan is \$10,000 to \$15,000.

The possibility of a community inform meeting was mentioned. This discussion will be continued at the Lake Association Meeting in March.

Under new business, the construction of permanent structures by individual residents on Lakeshore property was discussed.
