WATER SYSTEM - <u>ribarrett@aol.com</u> – Princeton Hydro sent requests for bids to 3 contractors for the dam repair, only one has responded so far.

The hydrant in front of Sullivan's home is dripping and will need to be replaced when the weather permits. The hydrants are not suitable for firefighting however once a year they are used to blow out the water pipes to clear out dirt, debris and air.

We are waiting for bids for work on the tanks. Corrosion control gave us a bid for \$34,000 for the two vertical tanks and \$38,000 for the horizontal tank plus a few thousand for welding the pits. Once the bids are in the water water committee will make recommendations. One of the dysfunctional valves will need to be replaced before the horizontal tank can be drained. The other valve which controls Alpine also still needs to be replaced. When it is replaced the digging involved will give us a good indication of the condition of that water pipe.

A new resident Nick Stires, who is also a civil engineer, has offered to work on the VSA.
