The board approved the quote for the work on the valves by Alward. When they dig for the valves we will see the condition of the pipe along Alpine and get an estimate for any repairs needed. They will also take care of the leak on Lake Trail West by the Streuler's home while they are here. Once the valves have been replaced than the two vertical tanks will be painted and repaired for approximately \$34,000. Next year work will be done on the large horizontal tank which is expected to be around \$32,000.

Rick created a proposed "rules and regulations" for curb stops with information to assist homeowners understand and find the curb stops. The curb stops are quite different for each home and the sketches we have are based on the best information available and may not be accurate. He will make some revisions and the information will be put into the MKL Rules and Regulations for homeowners.

The work on the dam will begin shortly and cost approximately \$48,000 plus some expenses to the DEP. The DEP requires every Dam be inspected every two years and for MLK that is this year. The charge for the inspection is \$3,000.
