Ken had adjustments were made at the pumphouses to keep the water flowing smoothly.

A letter came from McCaferty's attorney. The property mortgage has been reassigned again and this bank is more aggressive. They are going to try to sell the house but need clear title. McCaferty' owes us \$30,000 in dues and \$60,000 in late fees and penalties however he went into bankruptcy and we now are only entitled to a small portion of that money. The attorney offered a few thousand dollars for us to clear the title. The board discussed the issue and unanimously voted to have Bobbi negotiation to get the best offer she could with the attorney and bank so the home could be sold.

The budget submissions will be discussed at the next meeting.

A lean is going on the Sumas property for past dues.

New business

Lori Denson sent an email saying that Tree Tech found one of our trees that is dying close to their home. He could not remove the tree because it stands over power lines and suggested she call JCP& who then, took the tree down and left it on their property. JCPL will chip and remove small branches up to 3 ft., cut manageable size wood pieces and pile them neatly on the property but <u>only</u> if done during the proper cycle. Everything was left on their lawn. It was an error and the board will pay for half of the cost to remove the tree. Residents <u>must</u> call the grounds chairman if there is a tree threatening their home on Lake property and the chairman will have it taken care of appropriately.
